Presidents Message cont.

It is the largest lake in the county of Haliburton and the 5th largest inland lake in Central Ontario Cottage country. It has approximately 73 miles of shoreline but only about 1,200 property owners. Many parts of the lake are well over 100 feet deep. Most of the land surrounding Kawagama is still owned by the crown. All these factors contribute to making Kawagama and Bear Lake and their environments pristine, with an abundance of fish, wildlife and clear, clean water. These are commodities that are hard to find today, especially within 3 hours drive from Toronto.

The mission of the KLCA is to "Preserve the Heritage." We do this with Committees that monitor our Environment with a focus on Water quality, Water Levels and Fisheries. We cooperate with the Algonquin Highlands Township and comment on development and minor variance proposals. We set out and maintain a lake marker system to assist with safe navigation. In order to stay current on lakefront property owner's issues, our Directors are also Directors on FOCA (Federation of Ontario Cottager Owners), CHA (Coalition of Haliburton Property Owners Association), and several MNRF (Ministry of Natural Resources and Forestry) committees.

On the community side of things, we hold a family Regatta every year on the August long weekend and are now hosting a fireworks display on the same evening.

We hope you continue to support your Lake Association by renewing your membership. You may also wish to consider joining the Board or one of our committees (see "about us" on the KLCA website).

Shoreline Health Study Lake-Wide Results John McHardy, Ron Schwark & Julia Sutton

You may recall that over the summer of 2015, the KLCA worked with the CHA (Coalition of Haliburton Property Owners Association) to study the health of the shoreline around Bear and Kawagama Lakes. The study was completed by two specially trained environmental science university students who were boated around the shorelines of Bear and Kawagama by generous volunteer cottagers and residents. The students used a protocol from Watersheds Canada and Canadian Wildlife Federation's "Love Your Lake Program" (www.loveyourlake.ca). The study classified the percent of shoreline according to 4 categories:

1. Natural – Shoreline is in its "original" natural state.

2. Regenerative – natural vegetation has been removed in the past but is in the process of growing back to a natural state.

3. Ornamental – All natural vegetation has been removed and replaced with a mowed lawn or other non-native species; structures such as docks, decks, boathouses, ramps, etc. are predominantly present at the shoreline.

4. Degraded – Natural vegetation has been lost; soil erosion, undercutting of the bank, and/or exposed roots or shrubs and trees is significant.

Studies have shown that unless 75% of the shoreline is in a natural state, water quality will degrade over time. There is a strong argument to include the "Regenerative" portion of the lake with the "Natural", as it is hopefully shoreline returning to its natural state (passively or actively). From a lake health perspective, however, Regenerative shoreline may not provide the same benefits as Natural because:

1. The vegetation has not been growing there as long; therefore roots may not be as well developed or deep.

2. The vegetation may not be as diverse as on a Natural shoreline (e.g. trees, shrubs, wildflowers, ferns, grasses, etc.). This is important, as precipitation should have contact with 3 to 4 levels before it hits the ground. Diverse vegetation also improves fish and wildlife habitat.

3. A Regenerative shoreline typically does not include the fallen logs, branches in the water or shade that provide vitally important fish habitat.

The results for each property on Bear and Kawagama (who did not opt out) were sent **only** to the property owner(s), and privacy has been strictly maintained. For those who opted out their properties were not studied. Lake-wide reports have now been prepared which show the results for each lake as a whole, i.e. all of the individual property reports have been averaged together to generate lake-wide results.

Here are the results for Bear and Kawagama Lakes:

Note: Average to Date is based upon 795 km of shoreline around 47 lakes in Haliburton County studied to date.

What Does This Mean?

1. The amount of **Natural** shoreline surrounding Bear and Kawagama is significantly less than 75 percent; however, Kawagama is in better shape than the average studied to date.

2. The percentage of shoreline in a **Natural** or **Regenerative** state for Bear totaled 77% and 81% for Kawagama – both better than the average studied to date.

3. Should we be concerned with these numbers? Not yet. While Regenerative may not preserve water quality as much as Natural, it is still shoreline that is progressing to a Natural state.

4. There is always room for improvement, especially as climate change progresses. If you are interested in improving the health of your shoreline, it's best to start with areas that have been classified as **Ornamental**. The property report sent to participating property owners provided extensive resource material for ideas on what to do and who to contact for assistance. If nothing else, we should all keep as much of our shoreline in a Natural and/or Regenerative state as possible and try to restore areas that we can. This will help Kawagama and Bear Lakes obtain 75% Natural as we move forward!

Dock Permit Update

Dock Permitting at MNRF — a process on the mend?

After a 2016 summer season filled with confusion and bureaucracy related to minor shoreline projects in Ontario, the Province has started taking steps to modify the overarching legislation (the Public Lands Act) to allow for more reasonable approaches to waterfront rules.

FOCA and their member groups have been pressing for clarity on dock permitting for over a year now! Bill 27, the Burden Reduction Act, has passed second reading and is now at Committee. FOCA will continue to follow this, and will keep you informed about developments. Electricity Pricing Update FOCA News – Dec 12, 2016

Hydro One has filed an updated plan related to the Ontario Energy Board (OEB) order to eliminate the Seasonal rate class. The full 196-page report is linked from the OEB website and is entitled:

HONI SeasonalRateReport UPDATE 20 161202

Some highlights include:

• The elimination of the Seasonal Class will result in over 70,000 customers moving to the R1 class and close to 84,000 customers moving to the R2 class, a large majority of whom are low-consumption customers.

• Hydro One's detailed analysis demonstrates that the move to all-fixed rates alone (already underway) addresses the key concern of some customers that low consumption customers are not paying their fair share of costs.

• The elimination of the Seasonal Class combined with the move to all-fixed distribution residential rates results in only a small benefit to the 70,000 seasonal customers moving to the R1 class, and very large negative impacts on the 84,000 seasonal customers that would move to the R2 class.

• Seasonal customers moving to all-fixed R1 rates will see only a small benefit from the elimination of the Seasonal Class s (i.e. a reduction of \$7 to \$9 in their bill)

• Seasonal customers moving to all-fixed R2 rates will see large unfavourable impacts from the elimination of the Seasonal Class (i.e. an increase of about \$65 in their monthly bill). In particular, low consumption seasonal customers will see a 177% increase in their monthly bill if they move to the R2 class with an all-fixed rate. Note: About 46% or 70,000 seasonal customers consume less than 150 kWh/month on average over the year. FOCA will be intervening in these OEB proceedings on behalf of their customers, and will be advising our members ASAP how they can productively contribute their ideas about their pending electricity bills.
